**AN ORDINANCE ESTABLISHING THE PULASKI COUNTY  
CEMETERY BOARD & APPOINTING INITIAL BOARD MEMBERS**

**WHEREAS;** K.R.S. 367.680, et al grants Kentucky Counties the authority to create a County Cemetery Board that may apply to the State of Kentucky, Governor's Office for Local Development and/or Department for Local Government and other State, Federal and private agencies for grants and funding to assist non-profit cemeteries that do not receive perpetual care funds, with restoration and maintenance of cemeteries, and;

**WHEREAS;** the Pulaski County Judge Executive and the Pulaski County Fiscal Court has a desire to restore, maintain and protect the non-profit cemeteries in Pulaski County, Kentucky, which do not receive perpetual care funds, and;

**WHEREAS;** the Pulaski County Historical Society and other public agencies, as well as many families in Pulaski County, Kentucky, have expressed a desire to have a Pulaski County Cemetery Board, now;

**THEREFORE, BE IT HEREBY ORDAINED;**

1. **CREATION OF BOARD:**

Pursuant to the authority granted in K.R.S. 367.680 et al there is hereby created **THE PULASKI COUNTY CEMETERY BOARD.**

2. **BOARD MEMBERS:**

The Pulaski County Cemetery Board shall consist of five (5) volunteer members, with no more than three (3) members representing the same political party.

Members shall be appointed by the Pulaski County Judge

Executive with approval of the Pulaski County Fiscal Court. Members shall have lived in Pulaski County, Kentucky for at least one (1) year prior to appointment and shall have demonstrated an interest in cemetery preservation, genealogy, local history or a related area.

3. **BOARD MEMBER TERMS:**

The appointed term of each Pulaski County Cemetery Board Member shall be four (4) years, except for the initial terms.

The initial appointed terms shall be as follows:

Two (2) members appointed to a one (1) year term;

Two (2) members shall be appointed to a two (2) year term;

One (1) member shall be appointed to a three (3) year term;

4. **BOARD MEMBER MEETINGS:**

The Pulaski County Cemetery Board shall meet at least three (3) times per year, and may meet at such other times as deemed appropriate.

The Cemetery Board shall comply with the open records laws for the State of Kentucky and with all laws, rules and regulations of the State of Kentucky and the County of Pulaski.

The above Ordinance was given first reading by the Pulaski County Fiscal Court at a regular meeting held on 7 day of October, 2009.

After being duly advertised, the above Ordinance was given second reading and duly adopted by the Pulaski County Fiscal Court on 27 day of October, 2009.
