

ORDINANCE NO. 12-03

AN ORDINANCE ANNEXING A TRACT OF LAND AND A PORTION OF A CORRIDOR OF HIGHWAY MORE SPECIFICALLY A PORTION OF A CORRIDOR OF WEST HWY 914 AND OLD MONTICELLO ROAD.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET KENTUCKY:

That the City of Somerset Kentucky does hereby annex to the City of Somerset Kentucky, pursuant to KRS 84A.420, the following boundary of unincorporated territory which is a tract of land known as the City of Somerset Water Treatment Plant and a portion of right-of-way/corridor known as Kentucky East Hwy 914 and Old Monticello Road, which is contiguous to current boundaries of the City Limits, and is territory that is urban in character or is suitable for urban development without unreasonable delay.



### City of Somerset, KY. Annexation Ordinance No. 12-03

A certain tract or parcel of land located in Pulaski County Kentucky lying adjacent to the City of Somerset City Limits and is more particularly described as follows:

The following description was prepared by Jody Dagley PLS 3138 of JD Land Surveying, Inc. Description was prepared utilizing record information from the Pulaski County Court Clerk's office, in Somerset, Kentucky, Department of Highway plan sheets for Hwy 914 and Highway plans for the Old Monticello Road and existing pavement shots using GPS, and noted on attached plat. The purpose of this survey is to delineate the limits of the annexation. It does not in any way reflect a determination of the individual parcel boundaries and should not be used for this purpose.
