CONTRACT

This agreement made and entered into as of the 11th day of March, 2013, by and between Pulaski County Fiscal Court and Russell County Fiscal Court, and effective as of April 1, 2013.

WHEREAS, the Fiscal Court of Russell County, pursuant to KRS 258.195, is required to establish and maintain an animal control shelter and Pulaski County does hereby agree to be the location of an animal control facility for monies received and such animal control facility conforms with KRS Chapter 258.

WITNESSETH, that for and in consideration of the mutual benefits which shall inure to the parties, the parties do hereby covenant and agree as follows:

- (1) The animal control facility shall be solely owned and operated by the Pulaski County Fiscal Court.
- (2) The Pulaski County Fiscal Court shall receive \$20,000 annually (for up to 600 animals; additional animals shall be assessed at a \$25 per head fee) from Russell County Fiscal Court to maintain day-to-day operations which shall include but is not limited to the following: Animal Shelter staff salaries and fringe benefits, liability insurance, animal care supplies, utilities, micro-chipping, and building supplies and maintenance. The Russell County Fiscal Court shall remit payment to Pulaski Fiscal Court on a quarterly basis for 1/4 (one-fourth) of the amount of \$20,000.00.
- (3) The Pulaski County Animal Shelter shall be staffed by no less than one (1) paid full-time coordinator, one (1) paid part-time veterinarian, three (3) paid full-time employees, and a minimum of one (1) part-time employee. Pulaski County Animal Shelter may also utilize state inmates, county inmates, KTAP workers, and other assigned employees on an as needed and availability basis.
- (4) Pulaski County and Russell County shall each employ its own animal control officer and pay the salary and fringe benefits for that employee.
- (5) Pulaski County and Russell County shall each supply its own animal control vehicle and shall each pay all costs associated with the vehicle.
- (6) Pulaski County shall maintain its facility in conformity with the requirements of the Kentucky Revised Statutes and any State and/or Federal Regulations.
- (7) All fees received for dog tags issued at the Pulaski County Animal Shelter

shall be remitted to Pulaski County Fiscal Court for general operating expenses.

- (8) Pulaski and Russell Counties shall be jointly liable for any injury or damage, either to persons or property, caused by any Russell County animal after it is received by Pulaski County Animal Shelter. Pulaski and Russell Counties shall each be solely and individually liable for any injury or damage either to persons or property caused by the animals in the care-transport of the individual animal control officers and shall hold the other county harmless from any liability for any loss caused by the responsible party in the performance of his/her duties.
- (9) All fees for adoption, boarding and donations from Russell County shall go toward the general operation expenses of the Pulaski County Animal Shelter.
- (10) This contract is for one (1) year and renews annually unless a forty-five (45) day written notice is given by either party as to the circumstances regarding the termination or any change in the contract. Any increase in the monetary consideration in this contract shall be limited to ten percent (10%) in any given year and will be tied to documented inflation.

WITNESS the signatures of the parties wherein they have agreed to as of the 11th day of March, 2013.




