The following specifications are for 5(five) Mechanical Chest Compression System. All Mechanical Chest Compression Systems need to meet Current AHA Guidelines for chest compressions. Pulaski County and Somerset-Pulaski County EMS reserves the right to refuse any or all bids. Bids should be submitted no later than 4:00 PM EST on January 4th, 2023.

Proposals must be received, time and date stamped in the Pulaski County Clerk's office on or before January 4th, 2023, at 4:00PM EST. Bids will be opened Fiscal Court Meeting January 10th, 2023

SPECIFICATIONS- Mechanical CPR Device

Requirements for Mechanical CPR Device:

- Mechanical CPR device must be new. No Exceptions.
- Must have a lithium-Ion polymer battery operating system. No Exceptions.
- Device must have at least two charging options of independent battery charger and external power cord to plug into the device. No Exceptions.
- Must have battery level of strength indicator on the top of the device. No Exceptions.
- Device weight must not exceed 18lbs. No Exceptions.
- Device must be easy to clean. No Exceptions.
- Device must have hard shell case for easy storage. No Exceptions
- If a shockable rhythm is identified, the shock must be able to be delivered with the Mechanical CPR device in operation. No Exceptions.
- No patient age limit requirements for device. No Exceptions.
- No patient weight limit requirements for device. No Exceptions.
- Device must have suction cup to assist in full chest recoil. No Exceptions.
- Device must have configurable settings to meet AHA guidelines for high quality CPR. No Exceptions.
- Device must have wireless connectivity. No Exceptions.
- Device must have the ability to produce QA/QI report. No Exceptions.
- Mechanical CPR device must include an option for on-site service performed by the original equipment manufacturer.
- Service option should include coverage all parts/labor/travel and battery replacement and include loaner device policy. No Exceptions.
